# Systematic Literature Review (SLR): When Schools Become Prisons: Exploring the Educational Dilemmas in Modern Society

#### ABSTRACT

The following study article reviews the challenges faced in the modern public education system in Indonesia. Schools, as formal educational institutions, are a concrete indication of educational failure in this country. In essence, the goal of school is to guide students to become intelligent individuals and have the ability to differentiate between right and wrong. However, ironically, education often makes individuals less educated and feel trapped in situations that make them less developed. In terms of methods, this research uses a qualitative approach by conducting interviews and collecting documents to collect data and information. The collected data is analyzed and interpreted to produce conclusions. Based on information from accurate sources, this research confirms the dilemma hypothesis in education in modern society by illustrating five main cases in the world of education. ## **RESEARCH METHODS**

The research process begins with searching for articles that are relevant to the topic you want to research.

A systematic review is a method that thoroughly investigates a particular issue or problem by identifying, evaluating, and selecting relevant problems. This method involves creating specific and clear research questions that are based on pre-existing criteria, and refer to studies. -Previous studies that have quality and are certainly relevant to the questions in the study.

This study applies the Systematic Literature Review (SLR) method, a structured, transparent and repeatable approach to collecting, assessing and integrating research and thinking that has been carried out by researchers and practitioners. The main thing is to identify, review and assess all relevant research. This research process involves a series of predetermined stages, including:

- The initial research question is how important is it for students to study modern education?
- The data population in this research consists of journals that highlight the importance of modern education for students to study in order to normalize modern education from an early age. The search for literature studies began using Google Scholar and the Publish or Perish application, limiting studies from 2007 to 2023.
- Then, after collecting various studies, researchers found 50 relevant articles on the theme of modern education on Google Scholar. Of the 50 articles, 20 articles were selected that best suited the research topic. The articles were then studied in detail, and 7 of them that were most relevant to modern educational material were selected for inclusion in the analysis and conclusions, while the remaining 30 articles did not cover the topic or research question. A diagram illustrating the exclusion and inclusion process during the Systematic Review stage (n: number of articles) can be found below.
