The third factor is economic, violence also occurs due to economic factors where someone will act to oppress or take away other people's rights.

Violence in schools generally takes the form of physical and psychological forms, but physical violence is often more visible and in the spotlight. This violence usually occurs when sanctions or punishments are imposed for certain violations. If the sanctions given are not appropriate to the level or conditions of the violation, this could increase the potential for violent acts to occur. There are several things that can be done or used as an effort to prevent violence, including :

- 1. There are legal actions or laws that specifically regulate sanctions for acts of violence against children, so that they can prevent acts of violence against children at school.
