The data source is the students of Azhariyah Islamic elementary school, Lubuklinggau City, as many as 21 students. This research is a survey using Google-form media. The results of the research revealed that students were able to distinguish between natural and artificial appearances through the role of social studies learning, and 9.5% chose the yes statement. It states that all students feel helped that social studies learning can ease them to understand and distinguish between natural and artificial. Students stated that social studies subjects helped increase their knowledge of natural and artificial sights. This result is in accordance with the notion that social science is all knowledge related to society that examines a set of facts, concepts, and events.

With this explanation, it can be seen that students are weak in recognizing natural characteristics that exist around their scope because natural appearances are only seen in general. Social studies learning by students is considered boring, less interesting, not so important, and relatively difficult (Sukmanasa, et.al: 2017).

The results of social studies learning for 5<sup>th</sup> grade students are not yet optimal, due to several factors, namely the selection of an inappropriate learning method or model that causes less interaction between students and teachers in the learning process, learning media that have not been used optimally, and a less conducive classroom atmosphere so the learning does not run smoothly and








Picture 4. The rivers are natural appearances








Picture 7. The port is an artificial appearance

Picture 8. Tourists' attractions are artificial appearance






Picture 9. Mount Merapi is a natural appearance

The students stated that Lake Toba does not include artificial appearance because they think Lake Toba is a lake that cannot be made by human
